

Calidus Announces Significant Regional Gold Potential Highlighted at Warrawoona

Event

Calidus Resources ("Calidus") has announced the completion of a Regional Target Generation Study over the Company's East Pilbara greenstone assets. Geologists are now rapidly following up the highest priority targets conducting mapping and geochemistry programs in advance of RAB and RC drilling planned for Q2/Q3 2018.

Comment

Historically, the Warrawoona tenements have barely been explored regionally, let alone using the latest geological techniques. Historic soil sampling only covers 20% of the lease area. Therefore it comes as no surprise that additional exploration targets have been identified. What is surprising is that 45 high-priority targets have been identified and that these will be ranked and evaluated in 2018.

The recent exploration has been focused on expanding the ore resources of the Klondyke which were very successful, adding 74% more gold, and programmes are now being prepared to further expand this resource base.


However, the historic lack of regional exploration always suggested that there would be additional opportunities on the leases. The high priority targets were picked using a number of criteria, including Astor, soil sampling, Aeromag, old workings, linements and GIS, with the priorities determined by prospectivity.

A geochemical contractor is scheduled for late March, 2018 start to rapidly turnover regional soil sampling program across high priority targets.

The high priority targets include KET 14 and KET 15 in the southwest of the lease area, where a strong +1 km long geochemistry anomaly with a historic shallow scout drill hole intersected broad zones of mineralisation including 40m @ 0.44 g/t Au from 0m to EOH.

It is very positive to see that the horizons at Warrawoona are being broadened. Last year it was correct to focus on Klondyke where easy ounces could be added to the resource, but it is time to turn more attention to the large lease area that Calidus controls. The 50,000m drill programme for 2018, large by any stretch of the imagination, is currently being accelerated, with RC drilling at Coronation having already started. With well over A\$9M of cash in the treasury, Calidus is well funded to support this significant exploration programme for 2018.
